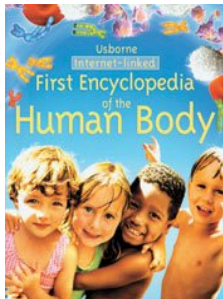
## Frequently Asked Questions

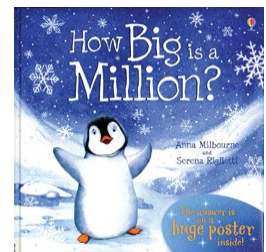

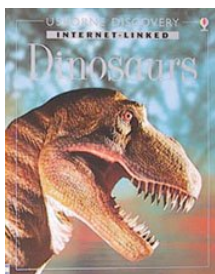


Q: Can I select other books from different companies?
